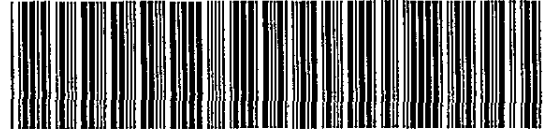

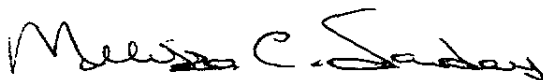

The initial registered agent is John F. Manss. The initial registered office of the corporation is 4623 College, Jacksonville, FL 32205.

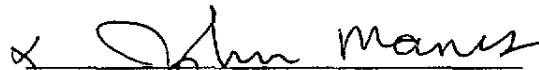
