# ARTICLES OF INCORPORATION OF BRAMEIR ENTERTAINMENT, Inc.

I

The name of the Corporation shall be BRAMEIR ENTERTAINMENT, Inc.

The Corporation shall be organized pursuant to the provisions of the Florida Business Corporation Code.

Ш

The Corporation shall have perpetual duration.

TV

The Corporation shall be organized for profit and for any lawful purpose and business not specifically prohibited to corporations under the applicable laws of the state of Florida including but not limited to (i) adult entertainment and promotion (nightclubs, live concerts, celebrity promotion; television and other media shows, (ii) movie and music production; entertainment of all kinds, (iii)engaging in manufacturing and distribution of books, magazines, video, games and other entertainment, (iv) contest and competition; image consulting (day spa, beauty salon, modeling studio, dance studio) commercial or other mediation services, as consultants or otherwise, for its own account or for others, (v) acquiring, owing, developing, improving, leasing, using and dealing in and with real and personal property, of all kinds whether tangible or intangible, and any interest therein, wherever situated, importing and exporting goods and services both foreign and domestic (vi) providing services of all kinds, and engaging in any activities related to or in any way arising from, any of the foregoing purposes.

The aggregated number of shares of common stock that the Corporation shall have authority to issue is 10,000 shares of common stock with par value of \$1.00 per share.

The Corporation shall not commence business until it shall have received not less than Five Hundred Dollars (\$500.00) for issuance of shares.

Subject to the Florida Business Corporation Code, the Board of Directors of the Corporation may from time to time at its discretion distribute a portion of its assets in cash or property, to its holders of common or preferred stock out of the capital surplus of the Corporation.
