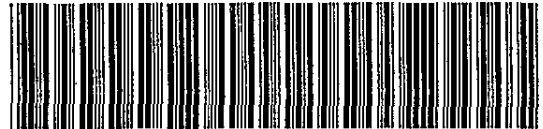


### ARTICLE X




