ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation understhe Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE 1. NAME. The name of the corporation is, SAL'S SNAPPY DOGS, INC., located at 12622 153rd Ct. N., Jupiter, FL 33478.
