ARTICLES OF INCORPORATION

OF
JMSB, INC.

THE UNDERSIGNED, acting as sole incorporator of a corporation to be formed under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation (the "Corporation") is JMSB, Inc., and its principal office and mailing address is 2989 St. Barnabas Court, Naples, Florida 34105.

The purpose or purposes for which the Corporation is organized are:
