
Article – Fourteen

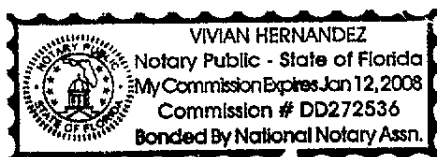


