# ARTICLES OF INCORPORATION OF ELIZABETH MARTIALAY, P.A.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

# ARTICLE I - NAME

The name of this corporation is ELIZABETH MARTIALAY, P.A. The mailing address of the corporation is 5445 Collins Avenue, #M 10, Miami Beach, Florida 33140.

#### ARTICLES II - GENERAL NATURE OF BUSINESS AND POWER

The general nature of the business to be transacted by this corporation shall be as follows:

- (a) To engage in every phase and aspect of the practice of legal services to any and all persons, firms, corporations, and other entities, and to the general public relating to legal services in the State of Florida and all of its political subdivision and before all administrative bodies, State and Federal, and to provide these services throughout the United States and the world unless prohibited by law; and

- (d) The foregoing shall be construed both as objectives and powers; and it is hereby expressly provided that the foregoing enumeration of special powers shall not be held to limit or restrict in any manner the powers of this corporation.

#### ARTICLE III - DURATION

This corporation shall have perpetual existence commencing on the date of execution and acknowledgement of these Articles of Incorporation.

#### ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1000 shares of \$1.00 par value Common Stock which shall be designated "Common Shares".

#### ARTICLE V - PREEMPTIVE RIGHTS
