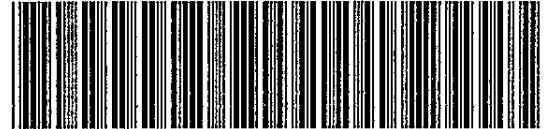

ARTICLES OF INCORPORATION
OF
RG & SONS FLOORING EXPERTS, INC.

The undersigned, acting as Incorporator under the provisions of Florida Statutes, Chapter 607, adopts the following Articles of Incorporation.

ARTICLE I

Name

The name of this Corporation shall be **RG & SONS FLOORING EXPERTS, INC.**

ARTICLE II

Principal Office

ARTICLE III

Purpose

The purpose for which the Corporation is organized is FLOORINGS INSTALLATIONS,

Shares

ARTICLE VI

ARTICLE VIII

Pre-emptive Rights

Each shareholder in this Corporation shall have the first right to purchase shares (and securities convertible into shares) of any class, kind or series or stock in this Corporation that may from time to time be issued (whether or not presently authorized), including shares from the treasury of this Corporation, in the ratio that the number of shares he/she holds at the time of issue bears to the total number of shares outstanding exclusive of treasury shares. This right shall be deemed waived by any Shareholder who does not exercise and pay for the shares pre-empted within thirty (30) days of receipt of a notice in writing from the Corporation stating the prices, terms and conditions of the issue of shares and inviting him to exercise his pre-emptive rights. This right may also be waived by affirmative written waiver submitted by the Shareholder to the Corporation within (30)

days of receipt of notice from the Corporation.

ARTICLE IX

Director Reliance on Corporate Records

A director shall not be liable for dividends illegally declared, distributions illegally made to Shareholders or any other action taken in reliance in good faith upon financial statements of the Corporation represented to him to be correct by the President of the Corporation or the officer having charge of the books accounts, or certified by an independent or certified accountant to clearly reflect the financial condition of the Corporation; nor shall be liable if, in good faith in determining the amount available for dividends of distribution, he/she considers the assets to be of ample value.

ARTICLE X

Amendment

These Articles of Incorporation may be amended in the manner provided by the law. Each amendment shall be approved by the Board of Directors and proposed by them to the Shareholders, and approved at a Shareholder's meeting unless all the Directors and all the Shareholders sign a written statement manifesting their intentions that a certain amendment to these Articles of Incorporation are made. All rights on Shareholders herein are granted subject to this reservation.

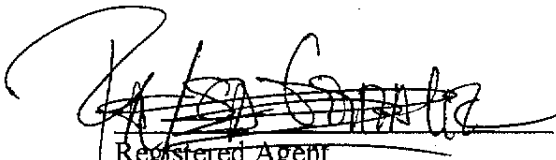

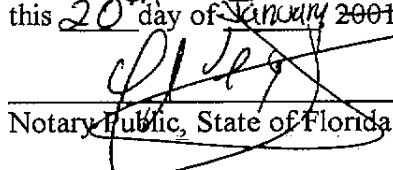
