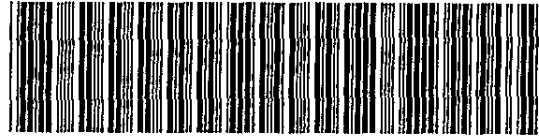

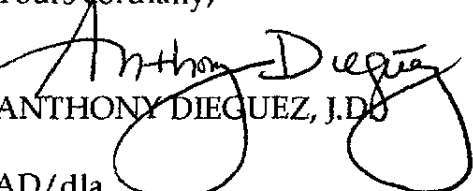

ARTICLES OF INCORPORATION
OF

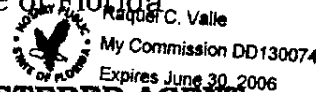
