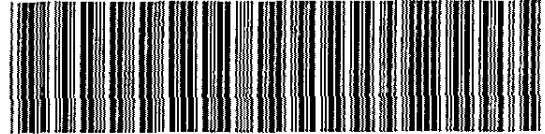

**ARTICLES OF INCORPORATION


#### **ARTICLE XII – REGISTERED AGENT**


