Pursuant to the provisions of the Professional Services Corporation Act of the State of Florida the undersigned Howard C. Richmond, being a duly licensed real estate professional does hereby make, organize and form a professional service corporation under the following Articles of Incorporation to wit:

ARTICLE I - NAME
