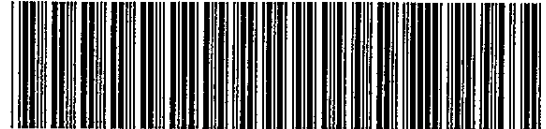

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is FUNAHASHI CONSULTING, INC. The mailing address of the corporation is 9007 Boca Garden Circle S, #A, Boca Raton, Florida 33496.

ARTICLES II - PURPOSE

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the laws of Florida and the United States.
