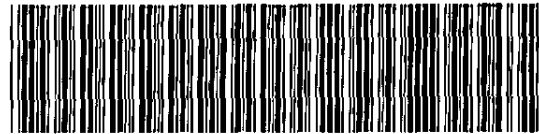

ARTICLE I
Name and Principal Office

The name of this corporation is KERR OAKS, INC. The principal place of business and mailing address of this corporation is 8467 Southwest 16th Avenue, Ocala, FL 34476.

ARTICLE II
Duration

This corporation shall have perpetual existence commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III
Purpose
