ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. **NAME AND ADDRESS OF CORPORATION**: The name of this corporation is: **JRMW ENTERPRISE, INC.** The mailing address of the corporation is P.O. Box 654, Bunnell, Florida 32110 and physical address is 1542 Mistletoe Street, Bunnell, Florida 32110.

2. **DURATION**: The period of its duration is perpetual.

3. **PURPOSE**: The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.

4. **CAPITAL STOCK**: The corporation is authorized to issue 100 shares of stock, all of one class, at One Dollar (\$1.00) par value.


