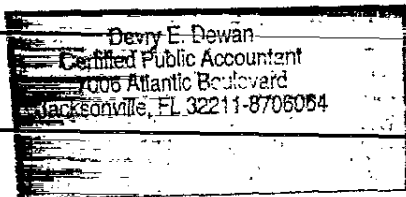

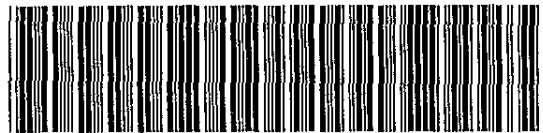

ARTICLE I - NAME

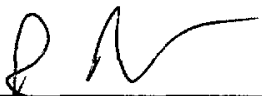

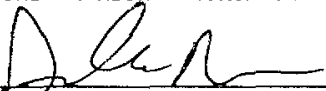

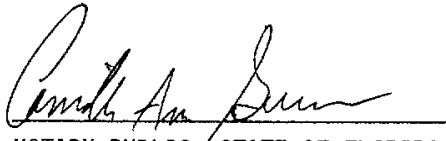
