FIRST: The name of the Corporation is: **"PRICEBUSTERS FURNITURE, INCORPORATED."**

SECOND: Its principal office in the State of Florida is : **7918 Kimberly Boulevard, City of North Lauderdale, County of Broward.**

THIRD: The nature of the business and objects and purposes proposed to be contracted, promoted and carried on, are to do any and all things herein mentioned, as fully as any natural person could and might do, in any part of the world, viz:
