## ARTICLES OF INCORPORATION OF LARRY GOUGH'S HANDYMAN SERVICE, INC.

#### ARTICLE I. NAME

NAME: The name of this corporation is LARRY GOUGH'S HANDYMAN SERVICE, INC.

#### ARTICLE II. DURATION


