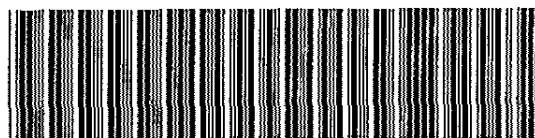

ARTICLES OF AMENDMENT OF
INTERIORS BY DECORATING DEN, INC., now known as

I, the President and the Secretary of INTERIORS BY DECORATING DEN, INC., now known as JEANNETTE CHANDLER INTERIORS, INC., a corporation organized under the laws of the State of Florida (the "Corporation"), do hereby make and attest these Articles of Amendment, and certify as follows:

(1) The name of the Corporation is INTERIORS BY DECORATING DEN, INC.

(2) The following amendment has been adopted in accordance with the requirements set forth in Chapter 607 of the Florida Statutes:

Article I of the Articles of Incorporation of the Corporation is deleted in its entirety, and replaced with the following new Article I:
