We, the undersigned incorporator(s), hereby associate ourselves together for the purpose of forming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit.

ARTICLE I

The name of the corporation shall be:

CY TRANSPORT SERVICE INC.

ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the State of Florida and of the United States of America.

ARTICLE III

The maximum shares which the Corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock, which shares shall be no par value.

All stock is to be issued as fully paid and exempt from assessment.

ARTICLE IV

The pledge, sale, transfer or other disposition of the capital stock may be governed and restricted by the by-laws or written agreement among the stockholders which shall be on file in the office of the corporation.

ARTICLE V

The amount of capital with which this corporation may begin doing business shall be not less than FIVE HUNDRED DOLLARS (500.00).

ARTICLE VI

This existence of the corporation is perpetual.

ARTICLE VIII

The business of the corporation shall be managed by a Board of Directors consisting of not be less than one director. ARTICLE IX






