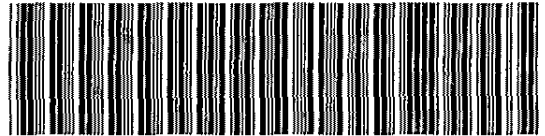

The undersigned incorporator, being a natural person competent to contract, do hereby certify that these Articles of Incorporation to form a corporation under the laws of the State of Florida.

I. NAME

The name of this corporation is S & J Steel Enterprises, Inc., and its principle place of business is 755 Lake Como Drive, Lake Mary, Florida 32746

II. PURPOSE

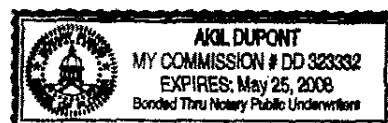
