AMENDMENT ARTICLE I

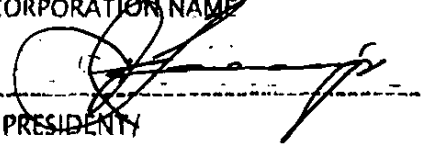
THE NAME OF THE CORPORATION IS CHANGED TO:
