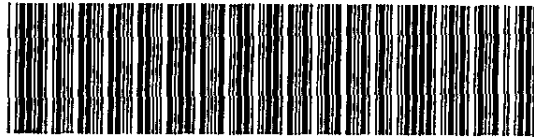



ARTICLES OF INCORPORATION

OF

YENNY ORTEGON, INC.

ARTICLE I - NAME

The name of the corporation is YENNY ORTEGON, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence, unless sooner dissolved according to law.

ARTICLE III - PURPOSE
