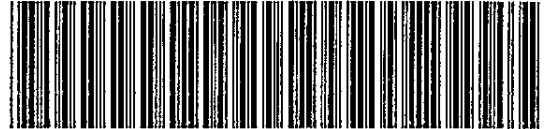

Articles of Incorporation  
of

The undersigned incorporators, in order to form a non-profit corporation under the Laws of the state of Florida, adopt the following Articles of Incorporation:

**Article I**

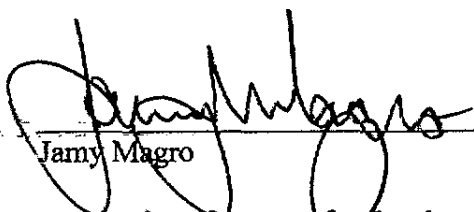
