Articles of Incorporation of Krewe of Mambi, Inc.

A Florida Non-Profit Corporation

The undersigned incorporators, in order to form a non-profit corporation under the Laws
- of the state of Florida, adopt the following Articles of Incorporation:

Article I

The name of the corporation shall be: Krewe of Mambi, Inc.
