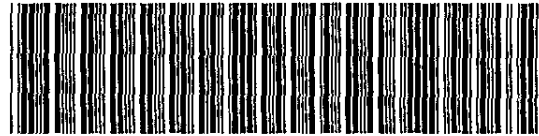

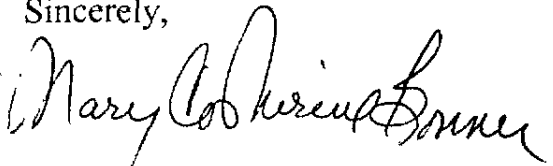

ARTICLE I- NAME OF CORPORATION

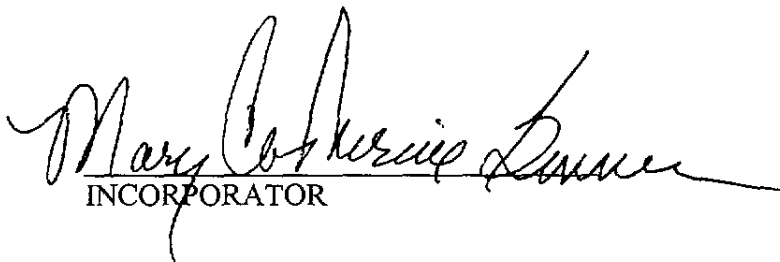

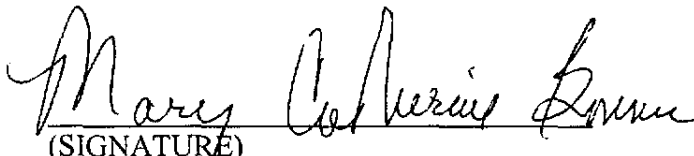
