The name of the Corporation is Palmetto Environmental Consultants, Inc. The duration of the Corporation is perpetual. The Corporation shall begin its corporate existence as of the date that these Articles are filed by the Secretary of State.

ARTICLE IIPrincipal Office

The address of the principal office and mailing address of the Corporation in the State of Florida is 2755 Oak Street, Jacksonville, Florida 32205.

ARTICLE IIIRegistered Office and Agent

The street address of the registered office in the State of Florida is 50 North Laura Street, Suite 2500, Jacksonville, FL 32202. The name of the registered agent at such address is MOTOLAW, Inc.

ARTICLE IVCorporate Purposes, Powers and Rights

1. The nature of the business to be conducted or promoted and the purposes of the Corporation are to engage in any lawful act for which corporations may be organized under the Florida Business Corporation Act.

2. In furtherance of its corporate purposes, the Corporation shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Florida Business Corporation Act.
