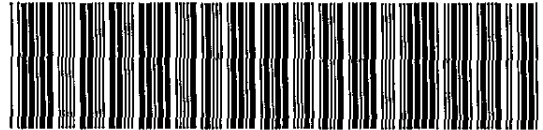


ARTICLE VIII - FISCAL YEAR




