ARTICLES OF INCORPORATION  
OF  
VENICE ORNAMENTAL IRON, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being natural persons, do hereby act as incorporators in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Venice Ornamental Iron, Inc.

ARTICLE II

The existence of the corporation shall begin on January 31, 2005.

ARTICLE III

The street address of the principal office of the Corporation is 1030 US 41 By Pass South, Venice, Florida 34292.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1000, all of which shall be Common Shares. 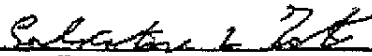
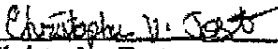
