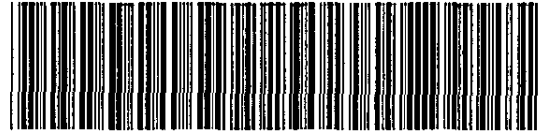

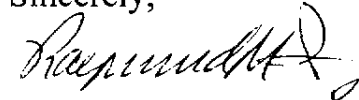

ARTICLES OF INCORPORATION

ARTICLE VI: ADDRESS

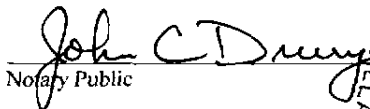
