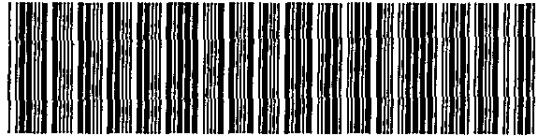

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be: LAW OFFICE OF MICHAEL D. MOORE, P.A.

ARTICLE II. PRINCIPAL PLACE OF BUSINESS

The principal place of business, which is also the mailing address, of this corporation shall be: 9225 Gulfshore Drive North, Naples, Florida 33108.

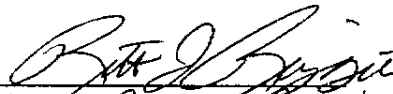
