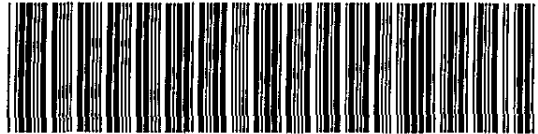

**ARTICLES OF INCORPORATION**

**ARTICLE I - NAME**

The name of this corporation is LAKES END ROOFING, INC.

#### **ARTICLE VIII - OFFICERS**




