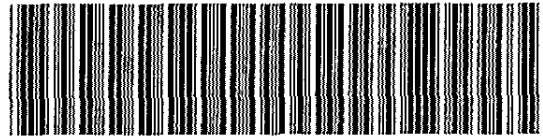

This corporation is organized for the purpose of
