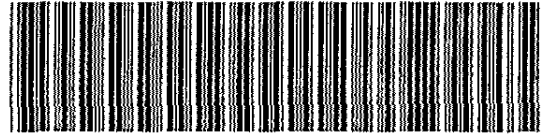

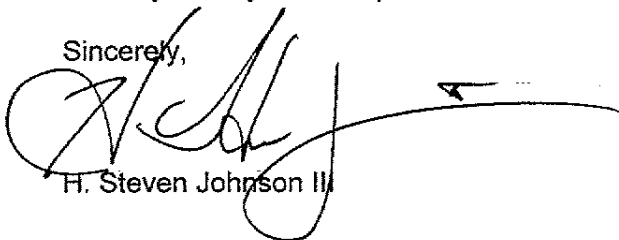

ARTICLES OF INCORPORATION
OF

GREETINGS FROM PARADISE, INC.

I, the undersigned subscriber to these Articles of Incorporation, being a person of legal age, do hereby desire to form a corporation under the laws of the State of Florida and do hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of this corporation is GREETINGS FROM PARADISE, INC.

ARTICLE II

The duration of this corporation shall be perpetual. The date and time of the commencement of the corporate existence shall begin January 31, 2005 or the effective date of incorporation whichever is later.

ARTICLE III
