I, the undersigned persons do hereby form the above corporation and to that end do hereby certify to the facts hereinafter set forth, as required by law.

Ι

The name of the proposed corporation shall be: BAILEY RECONSTRUCTION, INC.

ΙI

The general nature of the business to be transacted is as follows, to-wit:

- 1. Primary purpose will be to engage in the construction business and all related activities.
- To borrow or to raise monies for any of 2. the corporation, to issue bonds, notes or purposes of monies so borrowed and to other obligations for the payments thereof, and of the interest thereon, mortgage, pledge, conveyance whole or in part, by orin trust, of the whole or any part of the assignment property of the corporation, real or personal, including rights, franchises privileges contracts and other and its income, profits, stocks, bonds and other and also
