ARTICLES OF INCORPORATION OF COMPLETE CLOSING & TITLE SERVICES, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Act hereby adopt the following Articles of Incorporation.

ARTICLE I

Name

The name of the Corporation shall be: COMPLETE CLOSING & TITLE SERVICES, INC.

ARTICLE II

Nature of Business

The general nature of the business and the objects and purposes to be transacted and carried on are: To do any and all legal business allowed by the laws of the State of Florida and of the United States.

ARTICLE V

Address

The principal place of business of said Corporation shall be at 10448 Old St. Augustine Road, Jacksonville, Florida 32257, with branches at such other place or places within or without the State of Florida, or within or without the United States of America, as the Board of Directors may from time to time determine and resolve. be waived by affirmation of a written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
