ARTICLES OF INCORPORATION

ARTICLE I -- NAME

The name of this corporation, formed under the provisions of Section 621, Florida Statutes, is SAMUEL C. ULLMAN, P.A.

ARTICLE II -- PRINCIPAL OFFICE

ARTICLE III -- PURPOSE
