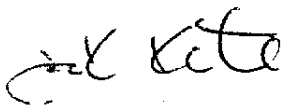

ARTICLE IX - AMENDMENT

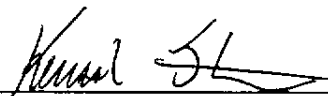

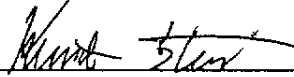
