

## ARTICLES OF INCORPORATION

#### HISTORIC BUILDERS, INC.

FILED WAS 12 WAS The undersigned incorporator hereby forms a corporation under Chapter the laws of the State of Florida.

#### ARTICLE I. NAME

The name of the corporation shall be: HISTORIC BUILDERS, INC. The address of the principal office of this corporation shall be 1445 Douglas Street, Jacksonville, Florida 32211 and the mailing address shall be the same.

#### ARTICLE II. NATURE OF BUSINESS

This corporation may engage in every aspect of the business of real estate, including without limitation, the purchase, construction, development, sale, lease, optioning, development, and rehabilitation of property for profit. In addition, this corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

#### ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one thousand (1,000) shares of common stock having ten (\$.10) cent par value per share.

#### ARTICLE IV. ADDRESS

#### **ARTICLE VII. INDEMNIFICATION**

The Corporation shall indemnify any director, officer or employee, or former director, officer or employee of the Corporation, or any person who may have served at its request as a director, officer, or employee of another corporation in which it owns shares of capital stock, or of which it is a creditor, against expenses actually and necessarily incurred by him or her in connection with the defense of any action, suit or proceeding in which he or she is made a party by reason of being or having been such director, officer or employee, except in relation to matters as to which he or she shall be adjudged in such action, suit or proceeding to be liable for negligence or misconduct in the performance of duty. The Corporation may also reimburse to any director, officer or employee the reasonable costs of settlement of any such action, suit or proceeding, if it shall be found by a majority of a committee composed of the directors not involved in the matter of controversy (whether or not a quorum) that it was in the interests of the Corporation that such settlement be made and that such director, officer or employee was not guilty of negligence or misconduct.
