The undersigned, acting as incorporator of Koehn Advisory Services, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE L NAME

The consideration to be paid for each share shall be fixed by the board of directors and such consideration may consist of any tangible or intangible property or benefit to the corporation, including each, promissory notes, services performed, promises to perform services evidenced by a written contract, or other securities of the corporation, with a value, in the judgment of the directors, equivalent to or greater than the full par value of the shares.
