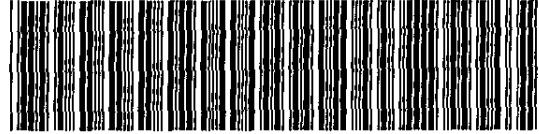

ARTICLES OF INCORPORATION

OF

The undersigned incorporator, for the purpose of forming a Florida profit corporation, hereby adopts the following Articles of Incorporation:

Article I

The name of the Corporation shall be ANNETTE ELLEN KRAVICK, P.A.
