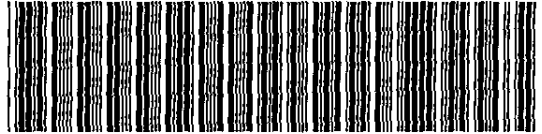

ARTICLES OF INCORPORATION

OF

BLACKBELL, INC.

ARTICLE I

The name of this corporation shall be BLACKBELL, INC.

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

The primary purpose of this corporation shall be to engage in the business of operating a real estate development service to the general public and the transaction of any and all lawful business for which a corporation may be incorporated under the laws of the State of Florida.

ARTICLE IV

The amount of capital stock authorized shall be 10,000 shares of common stock having a par value of \$1.00 Dollar (\$1.00) per share, making a total authorized capital stock of Ten Thousand Dollars (\$10,000.00).

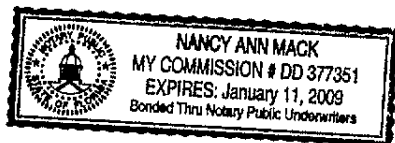
