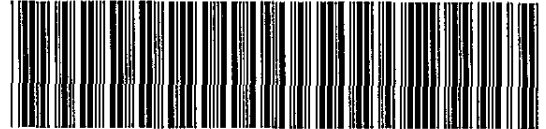

**ARTICLES OF INCORPORATION**

The undersigned, acting as incorporator pursuant to Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation:

Article I.

**NAME**

The name of this corporation is Dumplyn Enterprises Incorporated.

Article II.

**ADDRESS**

The street address of the principal office of the corporation is 5650 Elizabeth Rose Square Orlando, Florida 32810, and the mailing address of the corporation is the same.

Article III.

**CAPITAL STOCK**

This corporation is authorized to issue ten thousand (10,000) shares of authorized stock all of one class at a par value of ten cents (\$0.10) per share, to be designated "common shares."




