

# ARTICLES OF INCORPORATION OF

BIOSCIENCE, INC.

#### ARTICLE I - NAME

The name of this corporation is Bioscience, Inc.

#### ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business related to the practice of physical therapy.

# ARTICLE III - CAPITAL STOCK

The aggregate number of shares which the corporation is authorized to issue is 10000. Such shares shall be of a single class, and shall have a par value \$ .01 per share.
