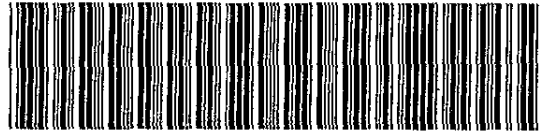

The name of this corporation is CUSTOM GROUNDS LAWN CARE SERVICE, INC. and the mailing address of the corporation shall be 16520 S. Tamiami Trail, #18-131, Fort Myers, Florida 33908.

The date of the commencement of corporate existence of the corporation shall be the date these Articles are filed with the Secretary of State.

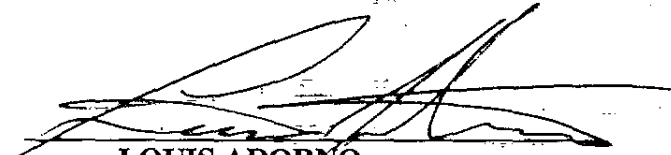

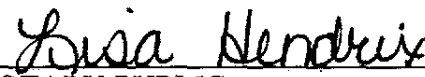

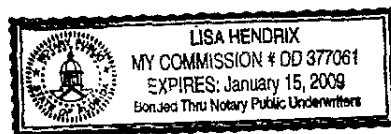
