#### ARTICLES OF INCORPORATION

OF

#### ARTICLE I. NAME

The name of this Corporation is ANN M. HEMENWAY, DVM, P.A.

#### ARTICLE II. DURATION

This Corporation shall have perpetual existence.

#### ARTICLE III. PURPOSE

The general nature and purposes of business to be  $\frac{1}{2}$   $\frac{1}{2}$   $\frac{1}{2}$  transacted, promoted, and carried on by the Corporation are as follows:

- a. To engage in every aspect in the practice of veterinary services and all its fields of specializations, as are engaged in by licensed veterinaries.
- b. To engage and render the professional serviced involved only through its officers, agents and employees who shall be psychologists in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this Corporation.
- c. To invest its funds in any type of investments permitted by law.

#### ARTICLE IV. CAPITOL STOCK

- b. The consideration to be paid for each share shall be payable in lawful money or property, labor or services.
- c. Shares of the Corporation's stock and certificates shall be issued only to psychologists in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this Corporation.
