ARTICLES OF INCORPORATION

OF

The undersigned, acting as Incorporator of a Corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I
NAME

The name of this Corporation is **GLOBAL REAL ESTATE NETWORK SERVICES CORP.**

DURATION



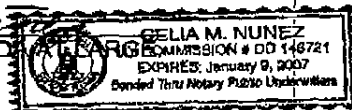


