ARTICLE I - NAME OF CORPORATION

The name of the corporation is **PENDER FINANCIAL SERVICES, INC.**

ARTICLE II - NATURE OF BUSINESS

The corporation is authorized to conduct any lawful business in the State of Florida which is not prohibited by law, rule or regulation.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding is 10,000 (Ten Thousand) shares of **COMMON STOCK**, each share having a par value of \$1.00 (One Dollar).
