

ARTICLES OF INCORPORATION

TALLAHASSEE, FLORIDA

OF

IRKEDALOT, INC.

ARTICLE I - NAME

The name of this corporation is IRKEDALOT, INC.

ARTICLE II - NATURE OF THE BUSINESS AND POWERS

This corporation is organized for the purpose of: to perform handyman services, and to conduct any other legal business.

ARTICLE III - DURATION

This corporation shall have perpetual existence.

ARTICLE IV - CAPITAL STOCK AUTHORIZED

Section 1. Authorized Shares

This corporation is authorized to issue 1000 shares of common stock with a par value of \$1.00 per share, which shall be designated "Common Shares".

Section 2. Voting Rights

Except as otherwise provided by law, the entire voting power for the election of officers and for all other purposes, shall be vested exclusively in the holders of the outstanding common shares.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

If a quorum is present, the affirmative vote of the majority of the shares presented at the meeting and entitled to vote on the subject matter shall be the act of the shareholders.

ARTICLE XV - MANAGEMENT OF CORPORATION BY SHAREHOLDERS

All corporate powers shall be exercised by or under the authority of, and the business and affairs of this corporation shall be managed under the direction of, the shareholders of this corporation.

ARTICLE XVI - INITIAL SHAREHOLDERS
