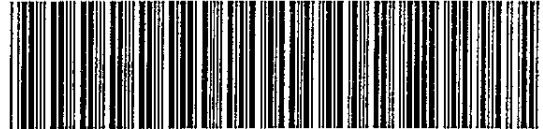

OF


