OF

ARTICLE I
CORPORATE NAME

The name of this corporation shall be:

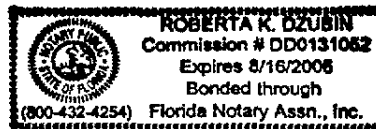
